WHAT ARE SOME OF YOUR GOALS AND VISIONS FOR THE CITY AND WHAT DO YOU HOPE TO GAIN FROM YOUR BOARD/COMMISSION EXPERIENCE?

The vast majority of the City is already built out but there are still changes and improvements that can be done. The greater Sacramento metropolitan area has a massive housing shortage which will only continue to worsen as California populations continue to grow. I would hope to encourage various new housing types that would maximize the efficient use of the remaining land that is zoned for residential land uses as well as help to foster a sense of community and use of outdoor spaces. I look at great plans, like the Electric Greenway, that will hopefully encourage residents to explore their community and outdoor spaces. Finally, I would hope to encourage small businesses to come and invest in some of the vacant business space. I would love to learn how and why decision-makers make their decisions are as large a scale as a 80,000-person city and how they work in and around the surrounding jurisdictions. I would love to be able to help the City grow in a sustainable and progressive way.

While I have not had experience on a public body, I was the elected representative of my co-operative living house to the larger co-operative living organization, a non-profit comprised of over 100 members. I learned, through bi-weekly meetings, how to listen, discuss, and compromise with other representatives that may or may not share the same viewpoints in order to make the best decisions possible for our organization and its future.

In 1989 Marcelle relocated to the Sacramento area to be closer to family and continue her career in the medical field. 

Specifically, with the decline of brick and mortar retail, Citrus Heights, like most jurisdictions, will be facing the prospect of closed retail locations. These can present great opportunities if re-purposed in a smart way that continues to serve the community and generate taxes. Conversely, if there aren't plans in place, these locations can become blighted, which then becomes a drain on city resources and a reduction in the quality of life.
